DATA PRIVACY NOTICE

The UHI and TOFARM organization is assuring the public that the personal information provided to our office are kept private and secured, and will be used solely for the Search & Award purpose in accordance to the **Data Privacy Act of 2012**.

- **1. Personal Information Collection:** Personal information may be collected in electronic/digital or paper-based form. Personal data requirement may vary depending on the type of award or category described in this manual.
- **2. Use and Purpose of Collection:** Personal data provided in the nomination forms and supporting documents shall be used in the preliminary judging and final judging for the TOFARM Awards System, data sharing with internal UHI/TOFARM Staff or external partner organization, data processing, updating or modification, storage and retrieval, profiling, retention or archiving, and disposal (or destruction) procedures.
- 3. Access, Disclosure & Sharing: Access, disclosure and sharing of personal information is restricted to authorized TOFARM staff and limited partner organization TOFARM counterparts. The UHI and TOFARM have in place several layers of restriction to physical and electronic access, including measures to preve DAGFZA3cess to the personal information.
- **4. Storage, Retention** & Disposal. The storage of Personal Information in paper-based form are locked in secured cabinets or roopRIMARY PAGE sonal Information in electronic/digital forms are secured using machine, network and software level protection keys. This to protect the personal data from accidental or unl DPA Page 1, processing, all erations, disclosure and or destruction.

Personal Information under the custody of the UHI and TOFARM shall be retained for a period of ten (10) years, and or as long as it is absolutely necessary in the fulfilment of the TOFARM function. Disposition of information including that containing personal information will require the approval of the Chief Advocate, in the manner prescribed by related laws.

- **5. Right of Client or Data Subject:** Client or Data Subject having absolute ownership of the Personal Information has the following rights, a) the right to be informed of personal data will be/are being/or were collected and processed; b) To gain reasonable access; c) the right to object; d) the right to demand for damages; e) Right to complaint; f) The right to data portability; g) Right to assign your rights to another entity; and h) may freely request for the status of their personal data, copy of the personal information, request for an alternation or erasure from the UHI and TOFARM.
- **6. Consent:** The Client or Data Subject gives freely their full consent once their name and signature is applied in the UHI and TOFARM official paper-based forms for Search and Awards requirement, and or upon submission or uploading of personal information in the official Website or Web Service Portal of the TOFARM.

7. Inquiries and Complaint: Owner of the personal information may inquire or request for information regarding any matter relating to the processing of their personal information. These inquiries or request may include the manner of process, the data privacy and security policies to ensure the protection of their personal information.


